Declaration of Conformity

We confirm hereby that none of our components (hoses and fittings) or final products (hose assemblies) produced by Parker PHDE contain substances like :

DEHP : This is limited only for the following hoses affected by DEHP: 395, DL5 100, 106, 120, 122, 125, 126, 128, 129, 130, 144, 151, 157, 160, 161, 162, 164, 167, 178, 202, 203, 222, 268, 296, 725, GPH

<u>LEAD</u>: this is limited only for the following metal fittings effected by lead: Carbon steel fittings (lead up to 0.35 %) and Brass fittings (lead up to 3.5 %). The above declared substances and substance thresholds comply with directive 2011/65/EU (RoHS3) in a higher concentration, as defined in Annex II of the above named Directive Limits of restricted materials used in our products: **Lead** – May be used in production of **STEEL metal fitting** components at 0.15% - 0.35% by weight and may be used in production of **BRASS metal fitting** components up to 4% by weight up (See Directive exception Annex III, n.6a-6al-6c).

While this directive applies to the use of certain hazardous substances in use in electrical and electronic equipment, Parker Hose Products Division takes no exemptions to the directive.
